Grocery Shopping and Delivery Service.

Gift of Time Ohio's employees, agents or designees will shop and deliver grocery orders placed with the Gift of Time Ohio Service. Prices of products sold may differ from those sold at time of past purchase. Delivery will be made to the delivery address that you specify when you place your first order. Payment for groceries and associated shopping and delivery fees is due at the time of delivery. You are responsible for ensuring that someone (a person 21 years of age or older with appropriate identification if delivery includes liquor and/or tobacco) is present at the delivery address to receive and pay for deliveries at the specified time of delivery. Anyone at the delivery address who receives the delivery is conclusively presumed to be authorized to receive and pay for the order.
